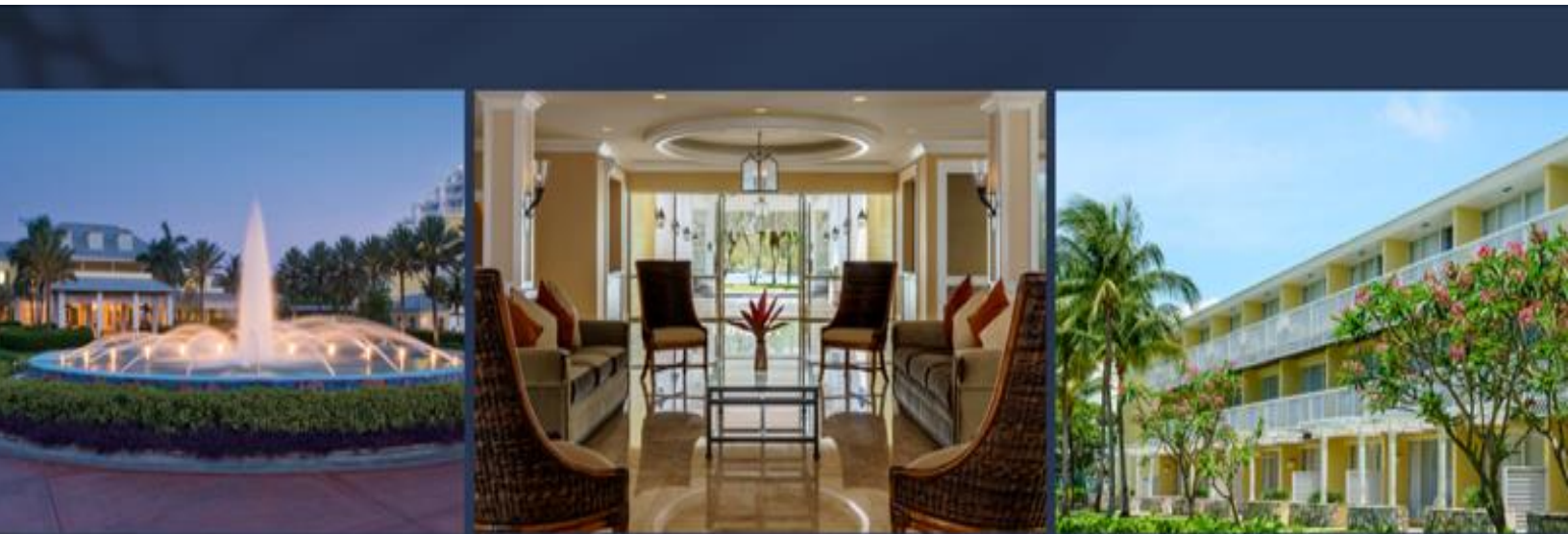
A credit card is required at time of booking.
